



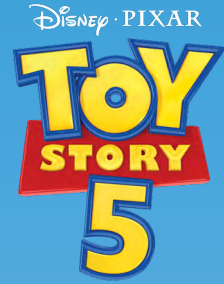

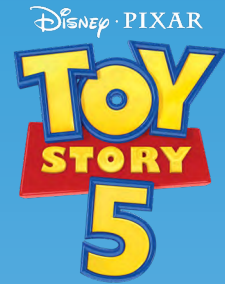

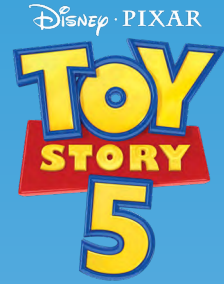


**FURTHER PRIZE

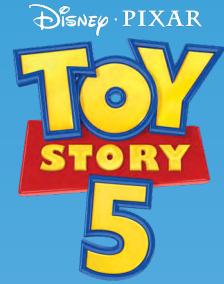
20.
